Fidante Partners Limited (ABN 94 002 835 592, AFSL 234668) (**Fidante Partners, we, our, us**) is the responsible entity of the Merlon Wholesale Australian Share Income Fund (ARSN 090 578 171) (**Fund**) and the issuer of this PDS. No other Fund is offered in this PDS. Our ultimate parent is Challenger Limited (ABN 85 106 842 371). We have appointed Merlon Capital Partners Pty Ltd (ABN 94 140 833 683, AFSL 343753) (**Merlon** or the **investment manager**) as the investment manager of the Fund. The offer or invitation to subscribe for units in the Fund under this PDS is only available to persons receiving this PDS in Australia. If you are a direct investor, all correspondence pertaining to your investment will be issued by us. If you have any queries regarding your investment or if you would like a paper copy of the PDS or the Additional Information booklet, you should contact us. If you are investing through an investor directed portfolio service (IDPS) or IDPS-like scheme (**indirect investors**), you should contact your IDPS operator with any query.

The information in this PDS is up-to-date at the time of preparation. However, some information can change from time to time. If a change is considered materially adverse we will issue a replacement PDS. For updated or other information about the Fund (such as performance), please contact your financial adviser, call our Investor Services team or visit our website using the details provided below. We will send you a copy of the updated information free of charge upon request.

Merlon has provided its consent to the statements about it in the form and context in which they are included. Merlon was not involved in the preparation and distribution of this PDS and is not responsible for the issue of this PDS, nor is it responsible for any particular part of this PDS, other than those parts that refer to it. # 1. About Fidante Partners

## Fidante Partners – the responsible entity

We are the responsible entity of the Fund. As responsible entity, we issue units in the Fund and are legally responsible to the unitholders of the Fund for its operation.

We have appointed Merlon as the investment manager of the Fund. We provide back office, marketing, distribution, administration and compliance support services to Merlon, giving it the freedom to focus on investing and managing the assets of the Fund.

A related entity of Fidante Partners has a partial equity stake in Merlon. Neither we nor any of our related entities, nor Merlon, guarantees the repayment of your capital or the performance of your investment or any particular taxation consequences of investing.

## Merlon – the investment manager

Merlon is a boutique fund manager based in Sydney, Australia, specialising in equity income strategies. Merlon commenced operation in May 2010, with the objective of providing high quality, tailored investment management services to investors. Prior to establishing Merlon, the majority of the principals worked together at Challenger Limited.

# 2. How the Merlon Wholesale Australian Share Income Fund works

The Fund is a registered managed investment scheme (also known as a **managed fund**) that is an unlisted Australian unit trust governed by a constitution together with the Corporations Act 2001 and other laws. Managed funds pool individual investors' monies which are then used to purchase assets in line with the Fund's investment objective.

If you decide to invest in the Fund, you will purchase 'units' in the Fund (rather than purchasing the assets directly) which represent a share of the value of the managed fund's collective asset pool. Certain rights are attached to the units and these rights are exercisable by the person who owns these units (referred to as **you, direct investor** or **unitholders** throughout this PDS).

For specific information relating to indirect investors, please refer to 'Indirect investors' on page 8 of this PDS.

The number of units you can purchase will depend on the amount being invested and the investment unit price calculated for the day we receive your valid application form.

## Investing

The minimum initial investment amount is \$10,000 or \$1,000 when a Regular Savings Plan is established. For additional investments, the minimum one-off additional investment amount is \$1,000 and the minimum Regular Savings Plan

amount is \$100 per month. We can vary or waive the minimum investment amounts at any time.

For more information on how to make an investment, refer to '8. How to apply' on page 7 of this PDS. All individual or joint investors in the Fund must be at least 18 years of age and all new investors must comply with our Customer Identification Program. Please refer to 'Customer Identification Program' on pages 2 and 3 of the Additional Information booklet available on our website.

## Withdrawing

Once invested in the Fund, you can generally withdraw your investment at any time by making a withdrawal (subject to certain requirements). The minimum withdrawal amount is \$1,000. The number of units you can withdraw will depend on the amount being withdrawn and the withdrawal unit price calculated for the day we receive your withdrawal request. In some circumstances, such as when there is a freeze on withdrawals, you may not be able to withdraw your funds within the usual period upon request. Refer to 'Withdrawal risk' on page 4 of this PDS for more information.

## Unit prices

As the market value of the assets invested in by the Fund rises and falls, so does the unit price. Unit prices are determined in accordance with the Fund's constitution and are usually calculated each New South Wales business day. We have a Unit Pricing Permitted Discretions Policy which sets out how we will exercise any discretions in relation to the unit pricing. You can request a copy of this policy by calling our Investor Services team.

## Processing

Generally, if your valid investment or withdrawal request is received in our Sydney office before 3.00pm Sydney time on a New South Wales business day (referred to as the **transaction cut-off time**), it will usually be processed using the unit price determined as at the close of business on that day.

If your valid investment or withdrawal request is received after the transaction cut-off time, or on a non-business day, it will usually be processed using the applicable unit price calculated as at the close of business on the next business day.

We will provide notice if we are to change the transaction cut-off time.

## Frequency of distributions

Currently, the Fund generally pays distributions quarterly. From 1 July 2012, the Fund will generally pay distributions monthly, with the first monthly distribution period ending 31 July 2012. There may be periods in which no distributions are made, or we may make interim distributions. We do not guarantee any particular level of distribution. Distributions will generally be paid as soon as practicable after the end of the Fund's distribution period.

## How distributions are calculated

Distributions you receive will generally represent your share of the estimated taxable income of the Fund and can be made up of both income and realised capital gains. Your share of any distribution depends on how many units you held at the end of the distribution period as a proportion of the total number of units on issue in the Fund at that time. In certain circumstances, some income and/or net realised capital gains may be held back until the final distribution at the end of June to allow for market volatility.

## 3. Benefits of investing in the Merlon Wholesale Australian Share Income Fund

### Significant features

- The Fund focuses on the 100 largest and most liquid companies listed on the Australian Securities Exchange (ASX).
- Merlon's investment approach is to build a portfolio of high dividend yielding companies whose share price is expected to rise and then reduce the risk associated with exposure to listed companies through the use of derivatives.
- The Fund aims to achieve a higher level of tax-effective income, predominantly from franked dividends, with a lower level of volatility than the S&P/ASX 200 Accumulation Index.

### Significant benefits

- Through its investment approach, Merlon aims to provide capital growth with inflation protection over the medium to long term.
- The Fund allows access to investment opportunities and diversification that individual investors usually cannot achieve on their own.
- The Fund offers access to investment professionals who specialise in Australian equities.
- The Fund generally pays distributions quarterly. From 1 July 2012, the Fund will generally pay distributions monthly, with the first monthly distribution period ending 31 July 2012.

- You may access up-to-date information on your account 24 hours a day, seven days a week through InvestorOnline, a secure online service. You will also receive regular information about your investment including quarterly statements and annual tax statements. Transaction statements showing all transactions for a specific period can be requested at any time.
- The way in which the Fund operates, including the rights, responsibilities and duties of the responsible entity and unitholders, is governed by a constitution together with the Corporations Act 2001 and other laws.

## 4. Risks of managed investment schemes

All investments carry risk. Different strategies carry different levels of risk depending on the assets that make up the strategy. Generally, assets with the potential for the highest long-term returns may also carry the highest level of short-term risk.

When investing in a managed investment scheme, it is important to note that the value of assets in the managed investment scheme and the level of returns will vary. No return is guaranteed. Future returns may differ from past returns and investors may lose some of their money invested. Additionally, laws (including tax laws) that affect registered managed investment schemes may change in the future, which may have an adverse effect on the returns of managed investment schemes.

Your level of acceptable risk will vary compared to other investors' risk appetites and depends on a range of factors such as your age, your investment timeframe, how comfortable you feel about exposing your investment to risk, the nature and size of other investments you hold and the extent to which the Fund fits into your overall financial plan.

The significant risks of investing in the Fund are:

- **Concentration risk**  
The value of a concentrated fund tends to be more volatile than the value of a more diversified fund. This is because a concentrated fund is generally exposed to a smaller range of assets and is therefore more sensitive to fluctuations in the value of those assets.
- **Counterparty risk**  
The risk that the other party to a contract (such as a derivative contract or physical security trade) fails to perform its contractual obligations either in whole or in part.

- **Derivative risk**

The value of a derivative is linked to the value of an underlying asset and can be highly volatile. Risks associated with using derivatives may include, but are not limited to, the value of the derivative failing to move in line with that of the underlying asset and the potential illiquidity of the derivative. While the use of derivatives can offer the Fund the opportunity for higher returns, it can also magnify losses to the Fund.

- **Fund risk**

The risk that changes to the Fund, such as termination, changes to fees or changes in government policies (including taxation), regulations and laws that may affect the Fund can have an impact on the potential investment return.

- **Liquidity risk**

The risk that the securities in which the Fund is invested, or the Fund itself, may become illiquid. This could have a detrimental effect on the value of the investments, or may impact an investor's ability to withdraw from the Fund.

- **Market risk**

The return on a particular security may be influenced by the return of other securities in investment markets (e.g. share markets and bond markets), similar regions or other asset classes.

- **Security risk**

The value of securities (also known as shares) is affected by market sentiment and other factors that may impact the performance of the actual company over short or extended periods of time. Shares in companies may also be impacted by many of the risks that the individual company is itself exposed to, such as changes in management or changes in technology and market trends.

- **Withdrawal risk**

The risk that we may not meet the generally applicable timeframe for withdrawal requests, may suspend withdrawals or may deem the Fund illiquid.

## 5. How we invest your money




When choosing what to invest in, you should consider the likely investment return of the Fund, the risks associated with investing in the Fund and your own personal objectives, risk preference and investment timeframe.

<b>Investment return objective</b>	The Fund aims to provide a higher level of tax-effective income with a lower level of risk than the S&P/ASX 200 Accumulation Index, whilst also providing the potential for capital growth and inflation protection over the medium to long term.
<b>Minimum suggested investment timeframe</b>	At least five years
<b>Benchmark</b>	S&P/ASX 200 Accumulation Index
<b>Risk level</b>	<b>Medium to high risk</b> – the Fund offers the potential for favourable returns over the long term, with a large proportion of returns coming from income, but may exhibit moderate levels of volatility over the short to medium term.
<b>Description of the Fund</b>	The Fund is intended to be suitable for investors who are happy to invest for at least five years, are seeking high levels of return, with a large proportion of returns coming from income (predominantly via franked dividends) and who are comfortable with moderate volatility including the possibility of periods of negative returns. To help you understand the following information relating to the Fund's investments, definitions of the important investment terms are provided on page 12 of the Additional Information booklet available on our website.

<b>Description of the Fund (continued)</b>	<p><b>Investment approach</b></p> <p>Merlon's investment approach is to build a portfolio of undervalued high dividend yielding companies and to then reduce some risk through the use of derivatives. Merlon aims for the Fund to be fully invested in large and mid-cap companies listed on the ASX, which are selected based on Merlon's investment philosophy.</p> <p>There are two elements to Merlon's investment philosophy:</p> <p><b>Value:</b> Merlon believes that stocks trading below fair value will outperform through time. Merlon measures value by sustainable free cash flow yield. Merlon views franking credits similarly to cash and takes a medium to long term view.</p> <p><b>Risk management:</b> Merlon believes that the impact of risk associated with investing can be reduced through derivative based hedging strategies. By entering into a derivative contract whose value moves in the opposite direction to the underlying asset, the risk of a reduction in the value of the underlying asset can be cancelled out in part or in full. Derivative based hedging strategies may also have the potential to provide additional returns and may deliver beneficial tax outcomes.</p> <p><b>Investment universe and portfolio construction</b></p> <p>The Fund's investment universe is primarily securities listed on the ASX, or those that Merlon expects to list within the next six months. The Fund can also invest in cash and over-the-counter derivatives related to securities listed on the ASX.</p> <p>Consistent with Merlon's philosophy the portfolio is constructed in two components:</p> <p><b>Fundamental equity portfolio:</b> Initial portfolio allocations are based on the results from Merlon's fundamental research. Single stock, sector and liquidity constraints are then applied to derive an underlying model portfolio. Subject to qualitative, tax and risk considerations, trades are implemented to continually align the Fund with this underlying model portfolio. Merlon does not short sell securities.</p> <p><b>Derivative overlay:</b> Stocks requiring a derivative overlay are identified based on criteria set by Merlon. Subject to qualitative review, appropriate derivative hedging strategies are applied.</p>

<b>Labour standards or environmental, social or ethical considerations</b>	While Merlon takes into account labour standards or environmental, social or ethical considerations when buying, retaining or selling underlying investments, it does not adhere to any particular set of standards. Merlon will consider incorporating financial forecasts of these issues impacting long-term returns and the determination of company-specific quality and conviction scores. These factors, and Merlon's process for considering them are detailed further in the Additional Information booklet.		
<b>Changes to investment policy</b>	The constitution of the Fund permits a wide range of investments and gives us, as responsible entity, broad investment powers. We may change the investment manager and/or vary the investment objectives, strategies, benchmarks, asset allocation ranges and processes of the Fund. We will give unitholders written notice of any material variation which we believe they would not have reasonably expected.		

<sup>1</sup> These are indicative asset allocation ranges for the Fund. If market movements, investments into or withdrawals from the Fund, or changes in the nature of an investment, cause the Fund to move outside these indicative ranges, or a limit set out in this PDS, this will be addressed by us or Merlon as soon as reasonably practicable.

## 6. Fees and costs

### Consumer advisory warning

#### Did you know?

Small differences in both investment performance and fees and costs can have a substantial impact on your long term returns. For example, total annual fees and costs of 2% of your fund balance rather than 1% could reduce your final return by up to 20% over a 30-year period (for example, reduce it from \$100,000 to \$80,000). You should consider whether features such as superior investment performance or the provision of better member services justify higher fees and costs. You may be able to negotiate to pay lower contribution fees and management costs where applicable. Ask the fund or your financial adviser.

## Additional explanation of fees and costs

**Management costs** – Management costs comprise the additional fees or costs that an investor incurs by investing in the Fund rather than investing directly in the underlying assets. These include the management fee, normal operating expenses, abnormal expenses and investment expenses. They do not include transaction costs (i.e. buy/sell spreads) or other costs that an investor would ordinarily incur when investing directly in the underlying assets. Management costs are payable from the Fund's assets and are not paid directly from your investment.

**Buy/sell spreads** – The buy/sell spread is the difference between the investment unit price and the withdrawal unit price and is stated as a percentage of the net asset value of the Fund. The buy/sell spread is not a fee paid to us. It is reflected in the unit price and is an additional cost to you. The current buy/sell spread for the Fund is +0.20%/–0.20%. This may vary from time to time and we will provide notification of any changes on our website.

**Commissions and other payments** – We may pay fees from our resources to some IDPS operators because they offer the Fund on their investment menus.



**Additional fees may be paid to a financial adviser if one is consulted. You should refer to the financial adviser's statement of advice which provides details of the fees payable.**

### Can the fees change?

All fees can change. Reasons for this might include changing economic conditions and changes in regulation. We will give unitholders 30 days' written notice of any proposed increase in fees. We cannot charge more than the Fund's constitution allows. If we wish to raise fees above the amount allowed for in the Fund's constitution, we would need the approval of unitholders. We also reserve the right to waive or reduce any of the fees and costs described in this PDS without prior notice.

## 7. How managed investment schemes are taxed



**Investing in a registered managed investment scheme is likely to have tax consequences and you are strongly advised to seek professional tax advice.**

The Fund generally distributes all of its income each year so that the Fund itself is not subject to tax. As an investor you will be assessed for tax on your share of the taxable income generated

by the Fund, including any net capital gains. The Fund does not pay tax on behalf of Australian investors. We strongly advise that you obtain your own professional advice regarding your position, as tax and social security laws are complex and subject to change, and investors' individual circumstances vary.

## 8. How to apply

If you are a direct investor, to make your initial investment:

- read this PDS and the Additional Information booklet available on our website;
- complete and sign the relevant application form (depending on what type of investor you are); all application forms are available on our website;
- include all required customer identity verification documents as outlined in the relevant application form (depending on what type of investor you are);
- if making your investment via direct debit, you will need to complete the direct debit facility section of the relevant application form; all direct debits are subject to the Direct Debit Request Agreement attached to the relevant application form;
- if making your investment via cheque, make the cheque payable to 'Fidante Partners <insert name of investor(s)>' and attach it to your application form; and
- post all documentation to:

If you are an indirect investor, you must complete the documentation which your IDPS operator requires.

Under the Fund's constitution we can accept or reject investments into the Fund at any time and are not required to give any reason or grounds for such a refusal.

To address money laundering and terrorism risks, verification of each investor's identity is a prerequisite for all new investors. If we do not receive all valid documents with your relevant application form or we are unable to verify your identity at any time, we may not be able to commence your investment or may not process any future withdrawal requests until we receive the required documents.

## Cooling-off rights

If you are a retail investor as defined in the Corporations Act 2001, you may have a cooling-off right whereby you can change your mind about your investment in the Fund and ask for your money to be repaid. This cooling-off right must be exercised within 14 days from the earlier of:

- when you receive confirmation of your investment; or
- the end of the fifth business day after the day on which your units were issued or sold to you.

Cooling-off rights do not apply to indirect investors.

## Complaints

If you have a complaint regarding your investment, you may notify us in writing. Our policy is to endeavour to acknowledge any complaint within two business days of receiving it and investigate, properly consider and decide what action (if any) to take and to communicate our decision to you within 45 days.

Indirect investors must send all complaints in writing to their IDPS operator.

## 9. Additional information

### Indirect investors

Investors accessing the Fund through an investor directed portfolio service (IDPS) or IDPS-like scheme (known commonly as a master trust or wrap account) may use, or be given this PDS when deciding to invest in the Fund. These investors are referred to as **indirect investors**.

Indirect investors do not become unitholders in the Fund nor do they acquire the rights of a unitholder. The operator of the IDPS (**IDPS operator**) acquires those rights and can exercise or decline to exercise them on behalf of indirect investors. Indirect investors do not receive distributions or reports directly from us, nor do they directly participate in investor meetings or the winding up of the Fund if this were to occur. Indirect investors should direct all their enquiries and complaints to their financial adviser or the IDPS operator, not to us.

In addition to reading this PDS, indirect investors should carefully read the IDPS operator's offer document, which explains the service and the fees payable by the indirect investor to the IDPS operator. To invest, indirect investors need to complete the documentation which their IDPS operator requires.

## Privacy

To enable us to process your investment, administer your investment, provide you with reports and comply with our obligations under the law, we may collect personal information about you. You can access, correct or update any personal information we hold about you by contacting our Investor Services team.

From time to time we, our related companies, or organisations with whom we have an alliance, may contact you to tell you about other products and services that might be useful to you. Please inform us in writing if you do not want any of this kind of marketing material.

If you decide not to provide certain information, we may not be able to process your investment or future withdrawal requests or may have to deduct tax at the highest marginal tax rate (plus Medicare levy) from any distributions paid to you. Please refer to 'What happens if you choose not to disclose certain information?' on page 6 of the Additional Information booklet available on our website.

### Disclosing your information

We may disclose the information we hold about you in a number of ways, including:

- where you consent to the disclosure;
- to your financial adviser;
- to companies that provide services on our behalf, for example, to companies that print and dispatch the statements or notices we send to you or to the custodian of the Fund;
- to related companies and/or the investment manager that may also provide you with a financial product or financial service;
- to companies and/or organisations with whom we have an alliance that may also provide products and services that may also be useful to you; and
- if the disclosure is required or authorised by law.
